## DAY 1 – ZAGREB

## DAY 3 – NP PLITVICE LAKES – TRILJ – DUBROVNIK

After breakfast drive to Trilj via Sinj. Short break in Sinj with the visit to the church and visit to Trilj. Departure to Dubrovnik. Arrival to hotel, dinner and overnight.

## DAY 4 – DUBROVNIK

After breakfast sightseeing of Dubrovnik including visit to the Dominican monastery, Franciscan monastery, City walls and panoramic view of the old city. Dinner and overnight at the hotel in Dubrovnik.

## DAY 5 – DUBROVNIK – SPLIT

After breakfast departure to Split. Sightseeing of Split including Cathedral of the St. Domnius and the Diocletian's palace. Afternoon free time leisure in the old city center of Split. Dinner and overnight in the hotel in Split.

## DAY 6 – SPLIT – TROGIR – ŠIBENIK – ZADAR

After breakfast departure to Trogir, short visit to the city center. Departure to Šibenik, visit to the St. Jame's Cathedral, drive to Zadar. Dinner and overnight at the hotel in Zadar.

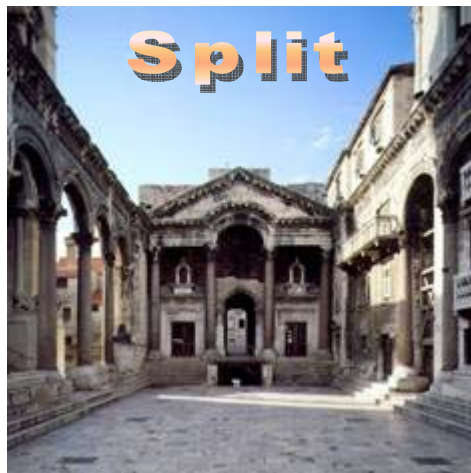


**DAY 7 – ZADAR – ZAGREB**
